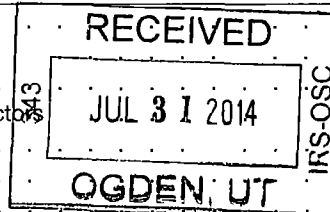

1. The expenses in 2012 were \$895 for the Harvest Day Dinner.

2. The revenue was \$8,495 in gifts from parishioners and friends of Our Lady of Victory Catholic Church in Davenport, Iowa plus \$5,719 in interest, dividends and capital gains.

3. The distributions made by the Foundation were only to Our Lady of Victory Catholic Church in the total amount of \$15,520..
