The organization acquired donated excess and obsolete business equipment and inventory (approximately 1,400 tons) from area businesses, thus diverting them from the waste stream. Member non-for-profit organizations selected needed, usable items from the organization's inventory paying only a small handling fee. Items that the non-for-profits do not want or cannot use are offered to the general public or other surplus markets in an effort to keep them out of the lanfill and to generate revenue to keep fees to the non-for-profit members low. Aproximately 1,000 charities benefited.
