The other employees are paid by the supported organization, The Saint Louis Art Museum. Salary surveys, studies and independent compensation consultants are periodically used to determine their compensation.

Part II Line B(ii) Brent Benjamin's other deferred compensation of \$219,930 consists of a retention plan, 403(b) plan and the estimated change in the actuarial value for the defined pension plan. The Board approved a retention plan for the Director of the Museum in December 2007. The agreement was effective in 2008. The 2012 credit is \$100,000. Annual amounts specified at the inception of the retention agreement are to be paid to the plan. The retention plan is 100% at risk with payments contingent upon Mr. Benjamin remaining in the Museum's employment through the expiration of the agreement in 2013. An additional \$15,000 was paid into a Cash Balance plan for the Director in 2012. The 403(b) contribution was \$50,000. The change in pension value of \$54,930 is a result of an estimate calculated on the difference in the present value of an annuity payout between the end of the year 2011 and the end of the year in 2012. The other reportable compensation of \$27,416 consists of a payout of accrued vacation (\$19,741) and gross up of a long term disability plan on his behalf for \$7,675. The long term disability plan is part of a larger plan for all employees. Amounts reported for other employees in column C is for the change in the actuarial value for the defined pension benefit from year end 2011 to year end 2012. Pension benefits were not available to Carl Hamm as of 12/31/2012 or 12/31/2011 due to his years of service. Other reportable compensation for Carolyn Schmidt, Carl Hamm, Bradley Haberer and Linda Thomas is for long term disability gross up.
