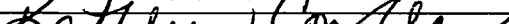

Recipients are chosen after completing a thorough application process and selected by a committee based on achievements depending on the requirements of the award in question.

**Development Grants**

The FAWCO foundation awards Development Grants to projects nominated by FAWCO member clubs. Recipients are chosen after completing a thorough application process and all nominated projects undergo a vigorous review. The recipients are selected based on a vote by the FAWCO member clubs as outlined in The FAWCO Foundation Administrative Guidelines.

**Target Water Project**

FAWCO, The FAWCO Foundation and its member clubs selected water as its target project. This project is a unique opportunity for FAWCO member clubs and FAUSA members to work together towards the goal of clean water worldwide.

In addition, to raising awareness about the importance of clean water worldwide the clubs specifically raised monies for "Wells for Clean Water", Cambodia. The FAWCO clubs pooled their efforts to contribute together to a UN Millennium Goal. The target water project officially ended at the end of the 2012 year and The FAWCO Foundation is collecting monies through June 30, 2013. A new target project supporting another UN Millennium Goal will be selected in 2013. Fund raising will begin in 2014 for this new project.
