4a (Code:) (Expenses \$ 92,771 including grants of \$) (Revenue \$ 64,542) GYMNASTICS PROGRAM - we provide strength, flexibility, fitness and gymnastic skill classes to ages from 15 months to adult. We provide a variety of classes that vary from one day per week to team levels who practice up to 12 hours per week. Classes run 12 months per year. The objective of the recreational classes is to promote fitness and learning in a fun and safe atmosphere and to build the self-esteem of all that enter our program. The objective of our team program is to prepare youth to compete against others in the USA gymnastics program as well as the High School program while building youth up into well rounded individuals who can handle pressure gracefully

4b (Code) (Expenses \$ 8,032 including grants of \$) (Revenue \$ 5,557) SCHOOL (GYM-N-LEARN) PROGRAM - This program consists of our Nursery School and After School classes. These classes are offered up to 5 days per week for approximately 3 hours per day. Our Nursery School classes are where children ages 2 1/2 to 5 years can learn the alphabet, colors, numbers and shapes. We have planned activities that focus on both academics and learning through play, stories, crafts, games, letter sheets, music and more. We also learn about nutrition and fitness. In each class they have a snack, 50 minutes of gymnastics or fitness and the rest is academic learning and learning through play time. We focus on having fun and preparing for Kindergarten. Our After School classes are offered to any child that is in pre-school through 5th grade. We provide a caring environment where children receive homework help, reading time and other fun activities. These classes include: snacks, academic work, gymnastics, fitness, art activities and open gym time. In 2012, this program had a total of 23 participants

4c (Code:) (Expenses \$ 1,597 including grants of \$) (Revenue \$ 3,388) CAMPS - There were 2 Mini-Camps held, 1 in May and 1 in December. Mini-Camps run 4 days for 2 25-2 5 hours per day. We had a total of 15 participants. There were 3 Day Camps, 1 in August and 2 in December. Day Camps run 3-5 days per week for 4-5 hours per day. We had a total of 22 participants. There were 2 Drop-Off Camps, 1 in December and 1 in March. Drop-Off Camps are held for 1 day for approximately 9 hours. We had a total of 41 participants. Summer Camp is held during our two 4 week summer recreational sessions. It runs up to 4 days per week for approximately 3 hours per day. We had a total of 10 participants. The camps included gymnastics, snacks, games, crafts and more
