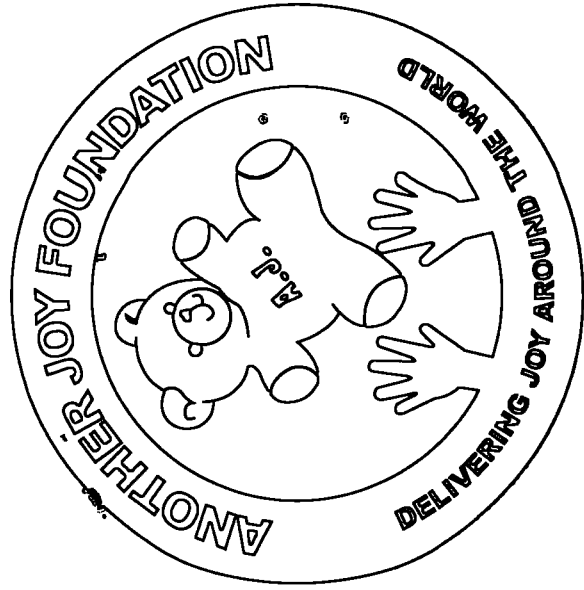

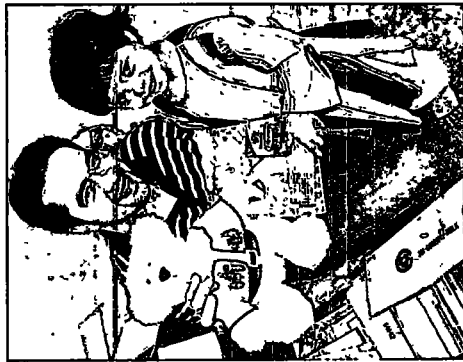

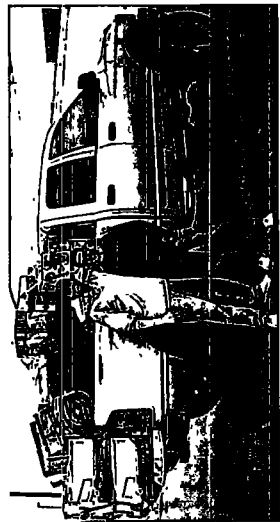
Another Joy Foundation is a registered nonprofit organization in Nevada with headquarters in Las Vegas. Our mission is to help deliver joy to children around the world.

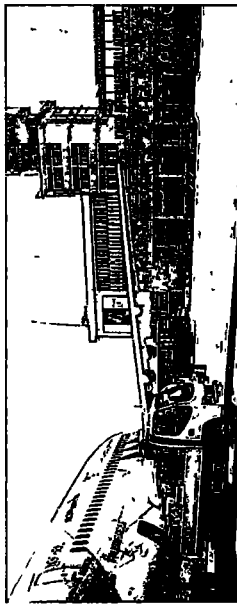
