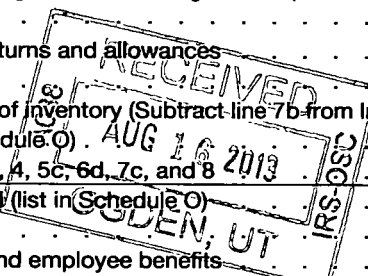

Levi and Diane Velasco, GLINTS President and Vice-President respectively, were summoned by CRASH Japan's President, Jonathan Wilson, to Japan. With many combined years of working in corporate settings, the Velascos were able to provide structure and stability to this young, emerging disaster relief agency based in Tokyo. Not only is CRASH a young organization, but also the majority of its employees and volunteer staff were in their 20s and early 30s. The Velascos returned to the United States in April, 2012 after serving Japanese victims of the earthquake, tsunami and the nuclear meltdown. They continued serving as international representatives of CRASH Japan until October, 2012.

Partnership Increase

One of GLINTS' goal is to assist like-minded organizations and answer their needs for donation processing and the vetting/hiring personnel process. GLINTS is a religious organization that recruits and places workers from/to various areas of the world. In 2012 GLINTS established partnerships with CRASH Japan, New Life Ministries (Japan) and the Philippine Relief and Development Services. (Please see www.glints.org.)

Beneficiaries

The GLINTS program in Japan benefited 20,000 or more Japanese survivors by the Velascos' service in maintaining relationships with donors from all corners of the world and the recruiting of volunteers to help in debris-clearing, property clean-up and survivor care.
