IT IS OUR UNDERSTANDING, THAT BY DEFINITION, THAT THIS RELATES THE TWO ORGANIZATIONS FOR THE PURPOSES OF THESE FILINGS. THE TWO CORPORATIONS OPERATE SEPARATELY AND THE FILING ORGANIZATION, WESTLAND GLOBAL, IS GOVERNED BY A BOARD CONSISTING OF MORE INDIVIDUALS THAN JUST TOM & TAMMY LEATHERBY, WHILE WESTLAND ASSOCIATES IS GOVERNED SOLELY BY THE LEATHERBYS. WESTLAND ASSOCIATES ALLOWS WESTLAND GLOBAL TO SHARE OFFICE SPACE AND THE USE OF EQUIPMENT AT NO EXPENSE TO WESTLAND GLOBAL. ADDITIONALLY, WESTLAND ASSOCIATES EMPLOYEE, BUNNY SHARP, SERVES AS A VOLUNTEER EMPLOYEE OF WESTLAND GLOBAL AND IS FREE TO WORK ON THE BUSINESS OF THE FILING ORGANIZATION DURING WESTLAND ASSOCIATES BUSINESS HOURS. NO OTHER SHARING OR EXCHANGE OF ASSETS EXISTS. WESTLAND ASSOCIATES HAS MADE AND WILL CONTINUE TO MAKE, AS ABLE, DONATIONS TO SUPPORT THE WORK OF WESTLAND GLOBAL AS PROJECTS ARISE WE WISH TO CONTRIBUTE TO. BUT WESTLAND GLOBAL DOES NOT CONTROL WESTLAND ASSOCIATES, NOR DOES WESTAND ASSOCIATES CONTROL WESTLAND GLOBAL - EACH IS A SEPARATE C-CORP ENTITY GOVERNED BY SEPARATE BOARDS WHO HAPPEN TO SHARE TWO MEMBERS - TOM & TAMMY LEATHERBY. AS TO THE NAME - WESTLAND GLOBAL WAS NAMED SUCH BY THE FOUNDERS DUE TO A LACK OF CREATIVITY IN THE NAMING PROCESS. IT IS OUR DESIRE, ONCE WE HAVE RECEIVED OUR DETERMINATION LETTER, TO BEGIN THE PROCESS OF CHANGING THE NAME TO SOMETHING MORE DISTINCTIVE. THE NAME OF THE ORGANIZATION CONNECTED THESE TWO ENTITIES IN A FASHION THAT WAS NOT INTENDED. THE SEPARATION WILL BE CLEARER ONCE THE FILING ORGANIZATION IS RENAMED.
