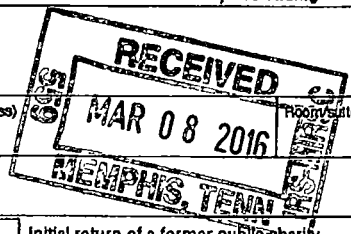

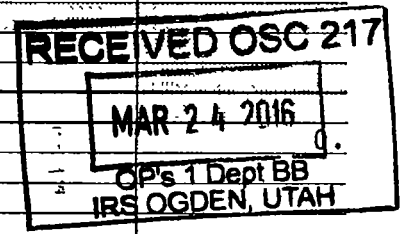
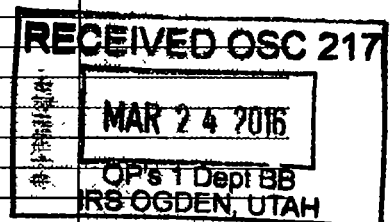

THE SUBJECT APPLICATION WAS BASED ON SUBSEQUENT FINANCIAL AND CHARITABLE ACTIVITY THAT WOULD BE CARRIED OUT AS A RESULT OF APPROVAL OF THE APPLICATION. FOLLOWING SUBMISSION OF THE FORM 1023 ADDITIONAL DATA AND SUPPORTING INFORMATION WAS PRESENTED TO THE SERVICE. IT WAS NOT UNTIL JUNE 25, 2012 THAT THE SERVICE PROVIDED THE FAVORABLE DETERMINATION LETTER CONCERNING THE TAX EXEMPT STATUS OF THE ENTITY.

THE ENTITY DID NOT HAVE ANY ACTIVITY DURING THE 2012 TAX YEAR - EXCEPT FOR THE APPROVAL OF THE SUBMISSION OF THE APPLICATION FOR TAX EXEMPTION.
