**EXPLANATION FOR FAILURE TO FILE RETURNS**

The Foundation had its tax-exempt status revoked for failure to file three consecutive years of annual returns, effective May 15, 2014. The IRS posted the Foundation's name on the list of automatically revoked organizations on August 11, 2014 and sent Notice CP120A dated August 18, 2014, to the Foundation regarding the revocation. The Foundation is in the process of filing for retroactive reinstatement as an exempt private foundation.

In support of the Foundation's belief that it had reasonable cause for its failure to file this required annual return, the Foundation states as follows:

The Foundation was incorporated on August 2, 2011, and received one contribution in 2011, but otherwise was not truly operational until 2012. In 2012 and 2013 it received several contributions and made various donations to other charitable organizations. The Foundation consisted of a volunteer Board of Directors and no full-time or part-time staff. Even though the Foundation exercised ordinary business care and prudence, it inadvertently overlooked the requirement to file annual tax returns.

The Foundation now receives accounting services from an independent accounting firm. After the Foundation received the Notice CP120A, the Foundation immediately took steps to notify its accountant regarding its annual return filing requirements and put procedures in place to ensure that the Foundation would not ever fail to file its annual return again.

Accordingly, the Foundation respectfully requests that any penalties associated with its failure to file annual tax returns for 2011, 2012, and 2013 be abated.
