

The organization has been successful in achieving its mission with many initiatives undertaken throughout the year. The organization hosted the Techniques For Success (TFS) conference for educators, administrators and therapists to learn best practices to teach students with Down syndrome and other special needs. The organization also launched a parent program in 2012 in collaboration with TFS, so that teachers and parents had the same resources to best support each child.
