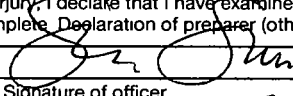

In 2012 we began organizing for the social media aspect through Facebook, Twitter, Google, and You Tube. We have received approvals as a non-profit from both Google and You Tube. We created the infrastructure for each of the social medias to be implemented in the next year.

Hundreds of men and women traveled to Hampton, S C for another news conference demanding the prosecution of a school Resource Officer who had been caught molesting many male middle school students during the school day and afterward. The culture of the county seemed to look the other way regarding sex crimes with child victims and Reclaim demanded action and accountability on behalf of police, prosecutors, and judges. Dr. Kaye helped expose the details of this man's crimes and numerous other victims came forward as a result. Lengthy and detailed interviews of victims done by Dr. Kaye provided details not only for prosecution, but also aided in the healing process.

We held several sessions just for men which were very successful and informative in making the huge adjustment between the experiences of different sexes.

Reclaim hosted the "Holocaust of Innocence Tour" and conference at our headquarters and provided exposure to many other non-profit organizations.

We held an end-of-the-year banquet in which we gave special recognition to police investigators and prosecutors who gave outstanding service when processing some of the 27 prosecutions requested during our march to the Sheriff's headquarters in February.

We created a great number of products in several categories to be distributed by our social media and website in the following year.

We have done a great deal of individual counseling free of charge in 2012.

In 2012 our funding was mostly through the grateful graduates of Reclaim who gave wonderfully to help pass on healing to the world. We continue to work on fund-raising techniques and projects for the following year.
