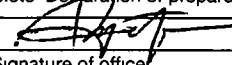

Part III Exempt purpose is to restore, rehabilitated, and resocialize victims of human trafficking and sexual exploitation in Mexico City, Mex

Part III, Line 28 Corazon Gomer is an outreach center in the red light district of Mexico City. It operates as a beauty salon, providing free or discounted services to the women who are prostituted in that area. All stylists are also trained counselors and therapists. The salon also has community room where group counseling and support groups are conducted. In 2012, 182 women have been served. Accomplishments include the start of therapy groups, 2 free medical campaigns, and vocational training classes.

Part III, Line 29 El Pozo de Vida project is a refuge house for underaged human trafficking victims. Girls are rescued by the Mexican government and local police department and are placed in the home. The home provides for all food, clothing, hygiene products, medical expenses, therapy services, and all costs of living incurred. Girls receive education from a teacher licenses with the Mexican government, intensive therapy and counseling services, activities, workshops and vocational training to prepare them for reintegration into society once their legal cases have been processed. The home also provides legal assistance for all cases being processed by the government. Since the home was first opened in 2010, the safehouse has served 25 girls.
