In 2012, REST opened its doors of the REST Restorative House which is a long-term, residential program. The housing program provides housing, case-management services, education, life-skills classes, job training, limited medical and dental, transportation fare, food, clothing, and allowances, incentives, support and more for 18 to 24-year olds. The residents can stay in the program for up to two years at no cost to the resident. In 2012, REST provided residential housing to 3 women. The expense includes the salary of one full-time residential house manager (hired mid-year), employee benefits and payroll taxes.

REST engaged 461 women and girls involved in Seattle's sex trade. We met these girls on the streets, in the clubs, at bikini barista stands and in the King County Juvenile Detention Center. In 2012, REST had 75 ongoing client relationships. Some of those relationships involved connecting girls to existing resources with the country, primarily locally. In addition, REST provided direct services to many of them, including counseling support and meeting felt-needs, such as food, transportation vouchers and hygiene supplies. In several cases, these girls were also connected to housing, job and educational resources.
