US Ignite Inc is a nonprofit organization formed to promote U S leadership in developing applications and services for ultra-fast broadband networks US Ignite fosters the creation of novel applications and digital experiences that have the potential to transform areas of national prionty such as healthcare, education and job skills training, public safety, energy, and advanced manufacturing The White House Office of Science and Technology Policy (OSTP) and the National Science Foundation (NSF) initiated the concept that forms the basis for US Ignite's activities and works with US Ignite to further these purposes US Ignite serves as a coordinating organization and a clearing house for network, funders, and in-kind contributions to this effort US Ignite directs contributions of network equipment to municipal, carrier, and research institution networks to give them access to the GENI (Global Environment for Network Innovation) network US Ignite conducted a major launch event with over 300 participants, hosted at the White House on June 14, 2012 This event brought together stakeholders from academia, government, industry, and local communities to kick off a conversation about applications for next generation networks US Ignite began working with innovators and developers on over 20 application development projects in its 10 target communities across the United States US Ignite brought together academic researchers, local entrepreneurs, and corporate sponsors to initiate development of applications that utilize aspects of high speed networking, software defined networking, and localized cloud computing
