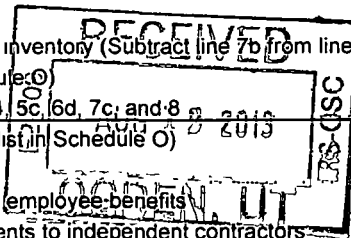

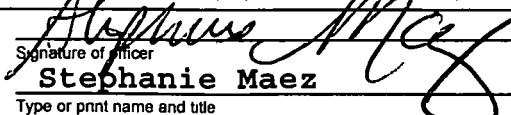

During 2012 we monitored the New Mexico legislative session and provided summaries of ongoing issues, including marriage equality for LGBT couples and campaign finance reform in elections, to subscribers and the public.

The organization worked to increase voter participation among Hispanic voters. Under our Hispano Media Project, we produced and distributed Spanish-language public service announcements encouraging Hispanics to register to vote. We followed those ads by organizing a voter registration drive targeting Hispanics and young voters on National Voter Registration Day and designed and implemented a communications plan to promote a Just Vote! public ad campaign and public event outside a polling station in Albuquerque, NM.

The Organization educated the public on new benefits available under the Affordable Care Act. We provided communications support to the Know Your Care project, educating New Mexicans on the new benefits available to them under the Affordable Care Act, including expanded access for students and seniors.
