We provide children with tangible hope by meeting their basic needs and equipping them with skills to succeed in the future, primarily through bilingual education. We seek to share the stories of these children with others, in hopes of exposing people to the needs of the world and providing them with a practical means to meet those needs.

In 2012 we founded, constructed, and accredited Colegio Bilingue Esperanza (the School of Hope), a bilingual elementary school for the children of Fundacion Salvacion orphanage, in Huehuetenango, Guatemala. A majority of these grant funds were used to purchase materials and pay the salaries of a 10-15 person construction team (the team varied in size based on the work load), who worked from mid-May through the end of December. The school has eight classrooms, offices for the secretary and principal, bathrooms, a main meeting area for assemblies, and a playground and garden area as well. Colegio Bilingue Esperanza opened in January 2013, and it now has 60, Pre-K - 6th grade students, who attend the school full time. All of these students come from Fundacion Salvacion orphanage, and all of them are on full scholarships because of U.S. sponsors who make monthly payments to cover their education costs. In addition to construction and labor costs, funds were also used to purchase land, pay for accreditation costs, and buy necessary school equipment and supplies (including textbooks and curriculum). Colegio Bilingue Esperanza is an official tax-exempt organization in Guatemala, which is currently owned by Brooks Baumgartner (the Executive Director of More Than Compassion). By 2014, More Than Compassion intends to create a Guatemalan affiliate that will own and operate Colegio Bilingue Esperanza. In the next three years, Colegio Bilingue Esperanza hopes to expand school enrollment to over 160 students.

4b (Code:) (Expenses \$ 28,529 including grants of \$ 28,529) (Revenue \$ 0)

On December 29, 2011, the founder and director of Fundacion Salvacion orphanage (Sandra Juarez de Temaj) died in a car accident. After Sandra passed away, the orphanage was in danger of closing down after 14 years of providing food, shelter, and care to orphans in Guatemala. However, More Than Compassion came alongside Fundacion Salvacion, and helped provide funding for the daily needs of the children. There are currently 110 children who live at Fundacion Salvacion, from 6 months to 19 years. Through a child sponsorship program where donors in the U.S. pay \$30 a month to provide for the basic needs of specific children, we've been able to cover over 70% of the operating costs of the orphanage. These costs include food, orphanage employee salaries, bills (water, electricity, internet, and phone), cleaning supplies, school tuition, construction costs, and administrative expenses. At the end of each month the orphanage presented us with receipts for all of their expenses from the month, and we reimbursed them for those expenses. In this way, we were able to track and ensure that all donor funds were used for their intended purposes. In total, we made grants for \$12,471 for food, \$8,431 for employee salaries, \$3,578 for bills, \$2,174 for cleaning supplies, \$1,302 for tuition, \$556 for construction costs, and \$17 for administrative expenses. Due to increases in child sponsorship numbers, we now cover over 90% of orphanage operating costs, and we hope to increase the number of children that Fundacion Salvacion can accept in the future.

In 2012, the only program service expense that was not part of a grant provided to Colegio Bilingue Esperanza or Fundacion Salvacion was money spent to host a four-day professional development seminar for Colegio Bilingue Esperanza teachers from the U.S. This training actually occurred in January 2013, and the payment for the training and curriculum was also made in January 2013, but part of our contract with the service provider included the cost of travel for a training instructor to come to Guatemala and lead the training. This intensive training equipped the Colegio Bilingue Esperanza teachers with the knowledge and abilities to effectively implement a total immersion, second-language acquisition curriculum. We are now seven months into the first school year, and the students at Colegio Bilingue Esperanza have experienced significant gains in both comprehension and production of English. We are still in the process of accumulating the mid-year data for the improvements in English language abilities, but all of the teachers and volunteers who visit the orphanage and school marvel at the English abilities of the children (especially considering that none of the students knew any English before the school opened). A survey of the U.S. teachers revealed that all of the teachers felt properly trained and equipped to teach English after the training. In the future, we hope to expand the scope of our training and professional development to include other subjects, and we also hope to provide a training in Spanish for the Guatemalan teachers at the school.

Part 1, line 2: Throughout 2012, More Than Compassion provided \$189,507 in grants to two organizations in Guatemala. \$28,529 was given to Fundacion Salvacion orphanage - a Guatemalan charity founded over 15 years ago, and located within Huehuetenango, Guatemala. More Than Compassion employed a reimbursement system with Fundacion Salvacion. With this system, Fundacion Salvacion would pay for all of the expenses up front, and then present a More Than Compassion volunteer with all of the receipts at the end of the month, at which time the More Than Compassion volunteer would review the receipts to ensure authenticity, and then provide Fundacion Salvacion with a reimbursement for the expenses. Throughout 2012, More Than Compassion made grants to Fundacion Salvacion for the following amounts: \$12,471 for food, \$8,431 for employee salaries, \$3,578 for bills, \$2,174 for cleaning supplies, \$1,302 for tuition, \$556 for construction costs, and \$17 for administrative expenses. In terms of its relationship with Colegio Bilingue Esperanza, More Than Compassion provided \$160,978 to help found, construct, and accredit Colegio Bilingue Esperanza, a bilingual elementary school for the children of Fundacion Salvacion orphanage. In order to monitor and track these funds, and ensure that funds were implemented with fidelity, More Than Compassion tasked five different full-time volunteers (all of whom came to Guatemala at different times throughout 2012) with the oversight and administration of these funds. Brooks Baumgartner, board chair and executive director of More Than Compassion, served as the on the ground director of this project for seven months out of the year. For the other five months, four other volunteers stepped in to monitor and oversee the funds. In order to ensure that funds were closely monitored, More Than Compassion has a physical and electronic copy of every receipt from every expense throughout the entire construction and accreditation process of Colegio Bilingue Esperanza. All of these expenses were then diligently entered into a detailed budget in order to track and monitor all of the expenses.

In 2012, More Than Compassion dedicated \$160,978 to build, accredit, and establish Colegio Bilingue Esperanza (the School of Hope), a bilingual elementary school for the children of Fundacion Salvacion orphanage. Colegio Bilingue Esperanza was officially accredited and recognized as a school by the Guatemalan Ministry of Education on October 10, 2012. Because of legal complications in establishing a U.S. organization as the owner of the school, More Than Compassion decided to employ the temporary solution of creating Colegio Bilingue Esperanza under the ownership of Brooks Baumgartner (board chair and executive director of More Than Compassion). However, over the past six months, through numerous conversations with Guatemalan lawyers and other U.S. based nonprofits who work in Guatemala, we've discovered the option of creating a Guatemalan affiliate of More Than Compassion, which will be able to legally own and manage the school, while sitting under the governance and authority of More Than Compassion's board of directors. We're already in the process of creating this Guatemalan affiliate, and we're hopeful that we should be able to transfer the ownership of the school from Mr. Baumgartner to this Guatemalan affiliate by 2014.

Colegio Bilingue Esperanza opened to the children of Fundacion Salvacion on January 14, 2013. The bilingual elementary currently hosts 60 students from the orphanage, grades Pre-K through 6th grade, and all of the students receive full scholarships to attend the school. These scholarships are provided by sponsors in the U.S. who pay \$30 per month to cover education costs of specific children at the orphanage. Colegio Bilingue Esperanza is a tax-exempt entity within Guatemala, and because it only receives students from within the orphanage, it does not generate any revenue or profits. Throughout 2012, Mr. Baumgartner kept detailed records of all expenditures for Colegio Bilingue Esperanza, including physical and electronic receipts for every expense that was incurred. Colegio Bilingue Esperanza has been open for more than seven months now, and it is staffed by seven U.S. teachers, one U.K. teacher, four Guatemalan teachers, one Guatemalan accountant/secretary, and one Guatemalan principal.

A definition of "business transaction" was not provided in the glossary, so we could not be certain of what classified as a business transaction. More Than Compassion did provide grants and other assistance to an entity (Colegio Bilingue Esperanza) that is owned by a current officer (Brooks Baumgartner), but these grants and assistance are explained in detail on Schedule F Parts I, II, IV, and V, and Schedule L, Part III and V

Part IV, line 35a: More Than Compassion answered "no" to this item because it does not have a "controlled entity." However, Brooks Baumgartner (board chair and executive director) is the current owner of Colegio Bilingue Esperanza. More Than Compassion is in the process of creating a Guatemalan affiliate that will become the legal owner of Colegio Bilingue Esperanza by 2014, but at this current time, More Than Compassion does not have a controlled entity. More Than Compassion addressed this matter on Schedule L, Part V, in hopes of being completely transparent and avoiding confusion.

Part V, line 4b: Brooks Baumgartner has "signature authority" over Colegio Bilingue Esperanza's bank account (which exists in Guatemala), along with the school's accountant. However, since the account was opened in October of 2012, it has not held more than \$10,000 at any one time. Because of this, More Than Compassion did not complete Form TD F 90-22.1.

Part VI, line 12c: More Than Compassion drafted a conflict of interest policy, which was sent (via email) to all of the board members before the first board meeting on July 29, 2012. At this meeting, the conflict of interest policy was discussed and certain changes and reforms of the policy were suggested and approved. The conflict of interest policy was unanimously approved by all seven board members that same night. Since that first board meeting, More Than Compassion has held regular board meetings every three months. At these meetings, board members are given the opportunity to voice any concerns they might have, including any potential conflicts of interest that might arise.

Part II, Column a, d, and e: Both of More Than Compassion's related organizations are located in Guatemala. Fundacion Salvacion orphanage and Colegio Bilingue Esperanza school are both tax-exempt organizations within Guatemala. However, because neither of these organizations are U.S. entities, they do not have an EIN, exempt code, or public charity status.

Part II, Column f and g: A clarifying note should be made about Colegio Bilingue Esperanza, and whether it is a controlled entity. It is completely accurate to say that Colegio Bilingue Esperanza is not directly controlled by any organization, and more importantly, that it is not directly controlled by More Than Compassion. However, it should be noted that Brooks Baumgartner, the board chair and executive director of More Than Compassion, was at one point the legal representative of Colegio Bilingue Esperanza, and is still the current owner of Colegio Bilingue Esperanza. More Than Compassion is currently in the process of creating a Guatemalan affiliate, which will take over ownership and management of the school. This change in ownership should be completed by 2014.

Part V, Line 2: It was challenging to determine whether to complete this line because Colegio Bilingue is not technically controlled by More Than Compassion. Also, Colegio Bilingue Esperanza is a tax-exempt organization within the country of Guatemala. However, because of the situation mentioned above with Mr. Baumgartner being the current owner of Colegio Bilingue Esperanza, and also given the fact that Colegio Bilingue Esperanza is not an official 501(c)(3) organization (because it exists in Guatemala), we felt that it was best to list the organization and the amount of assistance that was provided by More Than Compassion.
