

THE LANGUAGE TREE PROVIDES EARLY CHILDHOOD EDUCATION TO PRE-SCHOOL AGED CHILDREN IN A LANGUAGE IMMERSION SETTING, DRAWING A DIVERSE STUDENT BODY.
