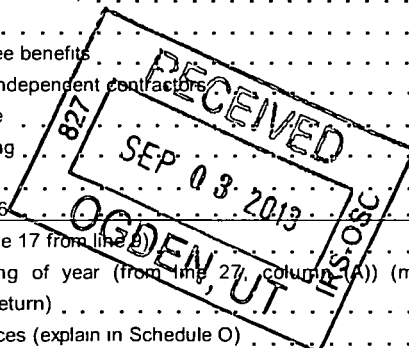

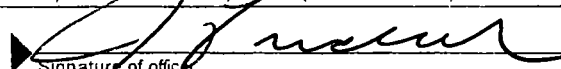

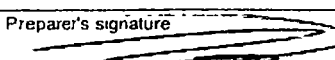

AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF

CENTER FOR TRANSFUSION AND TRANSPLANT MEDICINE, INC.

The Center for Transfusion and Transplant Medicine, Inc., a non-stock corporation organized and existing under Chapter 181 of the Wisconsin Statutes (the "Corporation"), hereby adopts the following Amended and Restated Articles of Incorporation, which supersede and take the place of its existing Articles of Incorporation and any and all amendments thereto.

ARTICLE I

Name

The name of the Corporation is Centers for Transfusion and Transplant Medicine, Inc.

ARTICLE II

Purposes

The Corporation is organized and shall be operated exclusively for charitable, scientific, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provisions of any future United States Internal Revenue Law) (hereinafter "Code"); and for the benefit of, to perform the functions of, or to carry out the purposes of the Blood Center of Wisconsin, Inc. and other similar entities engaged in blood transfusion, services or research (referred to as the "Supported Entities"), so long as the Supported Entities are organizations described in Code Section 509(a)(1) or (2) of the Code, to engage in activities relating to the aforementioned purposes; and to invest in, receive, hold, use and dispose of all property, real or personal, as may be necessary or desirable to carry into effect the aforementioned purposes.

Notwithstanding any other provisions of these Articles of Incorporation, the Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation that is exempt from Federal income tax under Code Section 501(c)(3), or (b) by a corporation contributions to which are deductible under Code Sections 170(c)(2), 2055(a)(2), and 2522(a)(2).

ARTICLE III

Powers

The Corporation shall have all powers conferred upon nonstock corporations organized under Chapter 181 of the Wisconsin Statutes and any successor provisions thereto now enacted or hereafter amended but shall exercise such powers only in fulfillment of its above-stated purposes.

The Corporation shall not engage in any of the following activities:

- (1) The Corporation shall not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of (or in opposition to) any candidate for public office.

(2) No substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting, to influence legislation; provided, however, that this provision shall not apply to activities consisting of carrying on propaganda, or otherwise attempting, to influence legislation, to the extent the Corporation has made an election pursuant to and remains in compliance with the restrictions of Code Section 501(h).

(3) No dividends shall be paid and no part of the net earnings of the Corporation shall inure to the benefit of any private individual within the meaning of Code Section 501(c)(3).

At any time when the Corporation is or becomes a "private foundation" within the meaning of Code Section 509(a) and Section 181.0320 of the Wisconsin Statutes, the following additional limitations on the Corporation's activities shall apply:

(1) The Corporation shall distribute its income for each taxable year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Code Section 4942.

(2) The Corporation shall not engage in any act of self-dealing as defined by Code Section 4941(d).

(3) The Corporation shall not retain any excess business holdings as defined in Code Section 4943(c).

(4) The Corporation shall not make any investments in such manner as to subject it to the tax under Code Section 4944.

(5) The Corporation shall not make any taxable expenditures as defined in Code Section 4945(d).

ARTICLE IV Members

The Corporation shall have no members.

ARTICLE V Board of Directors

The affairs of the Corporation shall be managed by a Board of Directors. The number and manner of election or appointment of Directors and their terms of office shall be as provided in the Bylaws, but the number of Directors shall not be less than three (3).

ARTICLE VI Dissolution and Liquidation

The Corporation may be dissolved upon the adoption of a plan to dissolve in the manner now or hereafter provided in the Wisconsin Statutes. In the event of dissolution of the Corporation, no liquidating or other dividends and no distribution of property owned by the Corporation shall be declared or paid to any private individual, but the net assets of the Corporation shall be distributed as follows:

(1) All liabilities and obligations of the Corporation shall be paid, satisfied and discharged, or adequate provision shall be made therefore.

(2) Remaining assets shall be distributed to one or more entities described in Code Section 501(c)(3) ("Charitable Entities") and/or one or more governmental units referred to in Code Section 170(c)(1) exclusively for public purposes ("Governmental Unit"), as determined in the plan to dissolve adopted in the manner set forth above in this Article VI. Any assets not disposed of pursuant to the foregoing provisions shall be distributed by the circuit court of the county in which the principal office of the Corporation is located to one or more Charitable Entities, or to a Governmental Unit, as such court shall determine.

ARTICLE VII Amendment

These Articles may be amended in the manner now or hereafter provided in the Wisconsin Statutes.

ARTICLE VIII Miscellaneous

Section 1. The name and street address of the Corporation's registered agent is Jacquelyn Fredrick, 638 N. 18th St., Milwaukee, Wisconsin 53201-2178.

Section 2. The mailing address of the principal office of the Corporation is 638 N. 18th St., Milwaukee, WI 53201-2178.

ARTICLE IX Permitted Distributions

The Bylaws of the Corporation may provide that the Corporation is authorized to make distributions under Section 181.1302(3) of the Wisconsin Statutes.

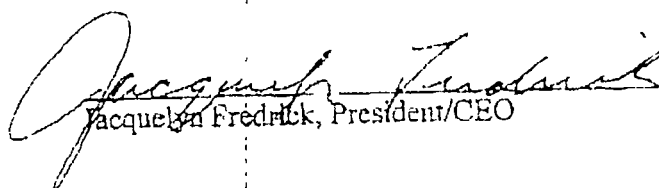
