In 2012, TAA incurred \$69,222 in total professional fees. \$52,072 of these fees represent compensation paid to the Executive Director and related administrative personnel. At this time, TAA does not have any employees and those fees are paid by other organizations pursuant to agreements between the parties. The TAA began operations in 2012 and the majority of the year was focused on developing an accreditation program for aftercare organizations that handle Thoroughbred horses as part of their core competencies. In 2012, professional fees allocated to management and general expenses is disproportionately high relative to program services expense as the accreditation program was not fully operational.
