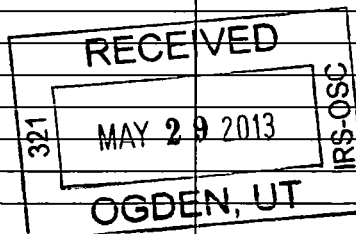

The Jesse David Hendley Foundation, Inc. (the "Foundation") is a residuary beneficiary of the Jesse David Hendley Revocable Trust, which has not yet made any distributions of its Trust assets to the Foundation. The Revocable Trust was funded with assets owned by the late Jesse David Hendley, who died on July 2, 2011.

The Merrill Lynch Trust Company, in its capacity as Successor Trustee of the Jesse David Hendley Revocable Trust, requested that the Foundation be formed as a matter of state law and that its tax-exempt status be determined by the IRS before calculating the distributions owed to the residuary beneficiaries of the Trust, including the Foundation.

These steps were accomplished so late in 2012 as to preclude any funding of the Foundation. That is the reason why the Foundation is reporting no income or expenses for the 2012 calendar year. As of May 14, 2013, the Foundation has not yet received any assets distributable from the Revocable Trust, but it anticipates receiving a lump-sum distribution by the end of this year.
