THE MYELOMA CROWD (WWW.MYELOMACROWD.ORG) AND ALS CROWD (ALSCROWD.ORG) WEBSITES OFFER AGGREGATED INFORMATION, THE LATEST NEWS AND INFORMATION ABOUT THE LATEST IN RESEARCH FOR EACH DISEASE COMMUNITY. ADDITIONALLY, THE CROWDCARE FOUNDATION CREATED USEFUL TOOLS PATIENTS CAN USE WHILE IN THE CLINIC: MY DOC NOTES AND CHEMO BRAIN DOC NOTES.
