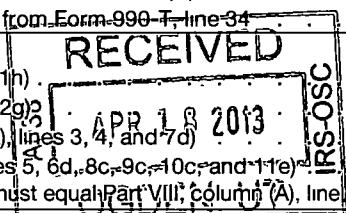

Dental Program for Ugandan Children: Over 300 children in two different villages received dental educaion, toothbrushes, and basic health education. These programs were conducted through focus groups, games, and crafts. Tooth decay is of particular concern in resource poor situations because of its negative impact on childhood nutrition, growth and weight gain. Among HIV infected children, the prevalence of oral lesions associated with the infection acts as indicator and a prediction of progression of the infection into AIDS. The 300 toothbrushes were handed out and coupled with dental and health education in two different villages. We are continuing to follow up with these children in dental and healthcare education to make sure they keep brushing. Dental hygiene can be linked to their improvement in nutritional growth, weight gain, and educational improvements, while decreasing the risk of opportunistic infections. We believe that these small steps in healthcare allow us to make relationships that facilitate long-term impact and change in a community's healthcare.

Medical Bills for Ugandan Children: While carrying out our dental programs, we came across children who were in life or death situations needing emergency medical attention, further medical assessments, medical procedures, or intravenous medications. We acted as patient advocates for these resource limited children to help save their lives. Providing finical funding and emmotional support to receive medical care and attention.
