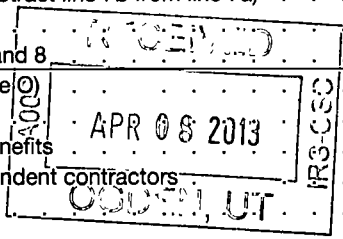

**AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF
MIDATLANTIC OPERA, INC.**

The undersigned, being of age eighteen or older, in order to form a corporation under Title 15A of the Revised Statutes of the State of New Jersey, as amended, supplemented and succeeded, for a lawful purpose other than pecuniary profit, certifies as follows:

1. Name: The name of this Corporation is:

MidAtlantic Opera, Inc.

2. Purpose: The Corporation is incorporated under the laws of the State of New Jersey for, and its activities shall be limited to, charitable, social, educational and artistic purposes of the nature set forth pursuant to Section 501(c)(3) of the Internal Revenue Service Code of 1986, as amended (hereinafter referred to as the "**Code**"), or the corresponding provisions of any applicable United States Internal Revenue Service Law, and not for pecuniary profit. Specifically, the Corporation was formed to provide classical music performances and arts education to the community and young artists in an around New Jersey, Pennsylvania and New York and to sponsor and produce a classical music festival to be located in Ocean Grove, New Jersey. The Corporation shall have and exercise all rights and powers as are now, or may hereafter be, conferred on or exercised by nonprofit corporations under the Act, other laws of the State of New Jersey or any other applicable laws, in furtherance of the Corporation's purposes.

3. Members: The Corporation shall have no members.

4. Management: The business and affairs of the Corporation shall be managed by a Board of Trustees, to be elected in the manner set forth in the Bylaws.


