

Youth Emergency Services, a nonprofit organization serving homeless and needy youth in the Omaha area, received a total of \$30,000 in support during 2012 from Tip Top Thrift Shop Inc. The liability on Line 26 column A from year-end 2011 was the promise to pay a nonprofit during 2012. This was all paid to Youth Emergency Services, plus an additional \$8,000, reported on Line 10.
