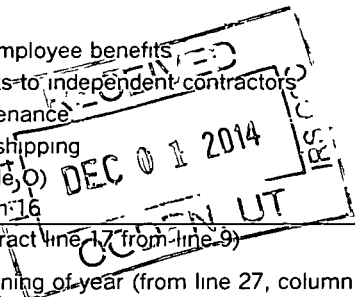

In addition, the bulk of the revenue raised will be used to refurbish the lower baseball field which is prone to flooding, as well as to install and maintain hiking trails.
