THE EXECUTIVE COMMITTEE SHALL HAVE AND EXERCISE ALL THE POWERS OF THE BOARD IN THE INTERIM BETWEEN BOARD MEETINGS SUBJECT TO SUCH LIMITATIONS AS THE LAWS OF THE STATE OF KANSAS OR RESOLUTIONS OF THE BOARD MAY IMPOSE, EXCEPT THAT THE EXECUTIVE COMMITTEE SHALL NOT HAVE THE POWER TO ADOPT THE BUDGET NOR TAKE ANY ACTION WHICH IS CONTRARY TO OR A SUBSTANTIAL DEPARTURE FROM THE DIRECTION ESTABLISHED BY THE BOARD OR WHICH REPRESENTS A MAJOR CHANGE IN THE AFFAIRS, BUSINESS OR POLICY OF THE CORPORATION. THE EXECUTIVE COMMITTEE SHALL SUBMIT REPORTS ON ACTION TAKEN TO THE BOARD. NOTICE OF TIME, PLACE AND PURPOSE OF THE MEETING SHALL BE GIVEN EACH MEMBER OF THE EXECUTIVE COMMITTEE NOT LESS THAN THREE (3) DAYS BEFORE THE MEETING. SPECIAL MEETINGS MAY BE CALLED BY THE PRESIDENT ON NOT LESS THAN THREE (3) DAYS NOTICE. THE PURPOSE OF THE SPECIAL MEETING SHALL BE STATED IN THE CALL FOR THE SPECIAL MEETING AND NO OTHER BUSINESS SHALL BE TRANSACTED EXCEPT FOR WHICH THE MEETING HAS BEEN CALLED.

THE PROPOSED AMENDMENT WOULD ADD THE FOLLOWING TO THE END OF THE SECTION:

BEGINNING UPON THE LATER DATE OF (I) JUNE 15, 2012, OR (II) THE CONSUMMATION OF THE INTEREST EXCHANGE AGREEMENT WITH BREAKTHROUGH CLUB OF SEDGWICK COUNTY AND ITS VOTING MEMBERS; AND ENDING ON DECEMBER 31, 2014, THE IMMEDIATE PAST PRESIDENT OF BREAKTHROUGH CLUB OF SEDGWICK COUNTY SHALL ALSO BE A MEMBER OF THE EXECUTIVE COMMITTEE, PROVIDED THAT SUCH PERSON IS A DIRECTOR OF THE BOARD.
