Programs included youth leadership, farmer education programs, educational trips to Topeka, KS and Washington D.C., and other educational conferences focused on rural and agriculture issues. The Foundation awarded over 40 scholarships totaling \$35,000, over 146 grants totaling \$50,207 and over 28 contributions totaling \$119,022.
