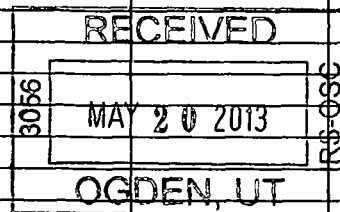

ISREAL D. MARKLEY CHARITABLE TRUST
GRANT PROCEDURE

Pursuant to authority granted by the Israel D. Markley Charitable Trust, it is the intent and purpose to conduct a scholarship program and award scholarships in a manner that will meet the requirements of Section 4945(g) of the Internal Revenue Code and the income tax regulations promulgated thereunder.

The following procedure is to be used by the Isreal D. Markley Charitable Trust in awarding scholarships to individuals:

1. Selection process. Scholarships will be awarded by an independent selection committee that will operate pursuant to a system of standards, procedures and follow-up designed to result in scholarships which are ~~awarded on an objective and non-discriminatory basis and which will in every~~ respect meet the requirements of Section 4945(g) of the Internal Revenue Code. Any high school graduate (or its equivalent) is eligible to apply for consideration by the selection committee. In awarding scholarships the selection committee shall take into account the following:

- (a) Prior academic performance.
- (b) Entrance and aptitude tests.
- (f) Financial need.
- (d) Selection committee's determination of individual's motivation, character, ability and potential (to be determined by personal interview or otherwise).

(e) Indication from the educational institution selected by the candidate that he or she will be accepted for enrollment.

2. Condition of award. The Isreal D. Markley Charitable Trust will make the award at such time as the student is enrolled and in good standing at the educational institution he or she has chosen to attend. The only conditions of the award are as follows:

(a) The recipient's legal residence be located within a 50 mile radius of Bennington, Kansas.

(b) The school selected by the recipient must be an accredited institution of higher learning located within the State of Kansas and in all respects qualifying as an educational institution described in Section 170(b)(1)(A)(ii) of the Internal Revenue Code.

(c) The recipient must pursue in good faith an established program of "higher education" at the school he or she has chosen to attend.

In the event the student should terminate his or her enrollment, the tuition refunded in accordance with the policy of the school will be returned to the Isreal D. Markley Charitable Trust to the extent of the award granted to such student.

3. Type of award. The primary type of award will be direct tuition scholarship grants.

4. Selection committee. The selection committee shall be comprised of not less than three nor more than nine persons as determined from time to time by the Trustee of the Israel D. Markley Charitable Trust. The selection committee shall include at least one person who is actively engaged with the Bennington, Kansas public school system (USD 240) in either an administrative, teaching or policy making capacity. The remaining members of the selection committee shall be from the public at large who are understanding of the mission and goals of higher education. The selection

committee shall operate in an objective and non-discriminatory manner and shall be a wholly independent body. Accordingly, no more than one member of the selection committee may be affiliated in any manner with the same educational institution.

5. Procedure for exercising supervision of awards. The Trustee will pay the grants directly to the recipient selected to receive the award. The recipient selected must agree to use the funds to defray the recipient's expenses at an educational institution in an established higher education program. The recipient's standing at the educational institution will be subject to verification by the selection committee and must be consistent with the purposes and conditions of the award.

6. Procedure for review of awards. The Israel D. Markley Charitable Trust shall obtain reports from each educational institution involved to determine whether the recipients have performed the activities that the grants are intended to finance. These reports will include progress made by the recipient toward achieving the purposes for which the grant was made. Such reports will be obtained at least once a year. A final report will be obtained describing the grantee's accomplishments with respect to the grant and accounting for the funds received under the award. If there is any indication that all or a part of an award is not being used in furtherance of the purposes of such grant, the Trustee will investigate. While conducting its investigation, the Trustee will withhold further payments to the extent possible until any delinquent reports have been submitted in accordance with applicable income tax regulations.
