The ASCAP Foundation is dedicated to nurturing the music talent of tomorrow by developing and supporting educational programs that provide effective learning opportunities consistent with our mission to students of all ages. The ASCAP Foundation has provided funding to sponsor 35 Music Education and / or Music Development programs and one community outreach program throughout the year with the goal of enhancing and promoting music education and providing the community with access to music. These 36 programs include 24 programs that received \$5,000 or less and 12 programs that received more than \$5,000.

4b (Code:) (Expenses \$ 329,001 including grants of \$ 293,500) (Revenue \$)**SCHOLARSHIPS, FELLOWSHIPS, AWARDS AND COMPOSER PROGRAMS -**

The ASCAP Foundation scholarship programs seek to ensure that opportunities for the study of music and instruments, songwriting, music composition, the business of music and related areas are available to students at all levels by providing Scholarships and Fellowships to 57 recipients ranging from \$1,000 - \$10,000. The ASCAP Foundation provides awards to emerging composers and writers consisting of cash awards to 89 recipients of composer and / or lyricist programs. These awards range from \$200 - \$10,000. Of these 89 awards, 87 awards are \$5,000 or less and 2 awards are for \$10,000 each.

The ASCAP Foundation Talent Development and Community Outreach programs provide aid and encouragement to music creators nationwide who are in various stages of their music careers including Workshops, (16); Commissioning and / or commissioning programs, (3) and sponsorship of Talent Development and Community Outreach programs, (25). By providing professional opportunities to emerging composers, lyricist and songwriters the ASCAP Foundation supports their careers and promotes their work.
