Public Education and Conference The NACAC conference in Crystal City, Virginia served about 750 adoptive parents, adoption professionals, and others committed to achieving permanence for children in foster care Participants attended about 80 educational sessions where they learned how to better support children with special needs, recruit and prepare permanent families for kids, replicate model programs, change the system to improve outcomes for vulnerable children and their families, and much more NACAC offered training to more than 1,600 adoption community members during the year on topics such as parent group development, adoption assistance, transracial parenting, core issues in adoption, and adoption competence NACAC staff and volunteers also help hundreds of prospective adopters find the information the need to navigate the adoption process, and the NACAC web site provides in-depth information on adoption issues to tens of thousands of site visitors each year

Support to AdoptUSKids NACAC also supported the efforts of AdoptUSKids to improve the availability of respite care to adoptive families around the U S Under contract with AdoptUSKids, NACAC continued to provide information and technical assistance to more than 100 respite grantees who had received grants to plan and implement respite care In addition, we researched and wrote a publication to help granteesand other parent support organizationsustain respite services after a grant In addition, NACAC supported lesbian, gay, bisexual, or transgender (LGBT) prospective adoptive parents who had contacted AdoptUSKids Staff answered their questions and connected them with LGBT friendly agencies in their area NACAC also provided logistical support to 10 regional roundtable meetings held by AdoptUSKids to enable state foster care and adoption managers to share information, practice strategies and resources with one another related to improving timely permanency for children in care

Adoption Support Network The Adoption Support Network (ASN) provided support to adoptive parents across Minnesota During 2012, ASN operated 27 support groups, held two retreats for 60 adoptive family members, and provided one-on-one peer support to about 800 adoptive families through more than 10,000 contacts The ASN private Facebook group had almost 500 members who share resources with one another and provide support durning difficult times These services for families raising children with special needs helped reduce families isolation, increased their ability to meet their childrens needs, increased families stability, and prevented adoption disruptions
