

1. Kids Night Out

Kids Night Out allows children to witness the results of hard work, dedication, and teamwork – qualities needed to excel in all aspects of life. This program takes place twice during the year, and serves over 1,200 underprivileged and underserved children from across North Texas.

2. Grants and Donations

The RoughRiders Foundation allocates a portion of its budget to grants and donations, which are awarded to numerous nonprofits throughout the year. The goal of this program is to assist organizations that help and support children and families, specifically in the area of education, good health and community service. Organizations awarded \$1,000 grants must submit a grant application form and are considered for these donations on a rolling basis through July of each year. In 2012, the Foundation donated \$12,500 to nonprofit organizations serving the community.

3. Student MVP

The RoughRiders MVP Student program is designed to be an instrument for teachers to reward, motivate and honor their students. The program utilizes RoughRiders tickets as the "tool". The program is targeted at fifth grade teachers and students.
