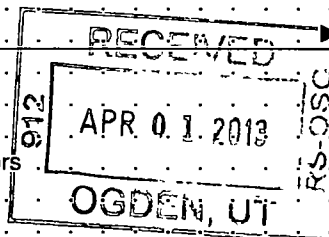

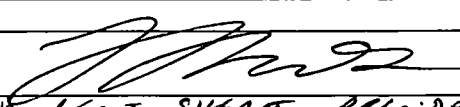
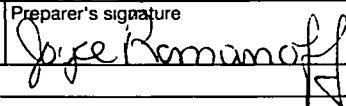

The Foundation also oversees the physician's training program whereby physicians have the ability to train health care professionals in the treatment of Lyme and other tick-bornes diseases which is assisted through the Society's membership of knowledgeable professionals in this field. This program enables those infected with this disease to be properly diagnosed and treated.
