Enterprise Community Loan Fund was formed to promote decent, safe, and affordable housing for low-income persons and families in furtherance of its mission and that of its parent organization, Enterprise Community Partners. Enterprise Community Partners and Enterprise Community Loan Fund believe that the provision of decent, safe, and affordable housing is the first step in enabling low income persons and families to break out of the cycle of poverty, and is also a means to combat community deterioration and revitalize distressed neighborhoods. In furtherance of these purposes, Enterprise Community Loan Fund provides loans to nonprofit developers and select mission-aligned for profit developers to support the overall development and financing of low income housing units and community space. Loans are also provided to other types of non-profit community based groups working to revitalize their community. Access to adequate funding is one of the greatest challenges facing community-based organizations. Enterprise Community Loan Fund has provided loans to support the overall development and financing of low income housing units and community space. The making of loans and directly providing capacity-building and "borrower readiness" expertise that effectively positions borrowers to successfully obtain financing is an important program activity of Enterprise Community Loan Fund in furtherance of its mission and that of Enterprise Community Partners. Enterprise Community Loan fund is a federally certified Community Development Financial Institution. It is also one of the largest nonprofit CDFIs in the country. Enterprise Community Loan Fund has participated in conferences, seminars, workshops and other training programs sponsored by its parent organization, Enterprise Community Partners, and other organizations. These conferences were attended by persons representing organizations involved in the low-income housing and community development fields. Through such conferences, seminars, workshops, online webinars etc., Enterprise Community Loan Fund communicated educational information, provided market analyses, organizational assessments, and business and strategic planning. They also offered training regarding the financial tools available to nonprofit-sponsored housing projects, as well as information regarding the development, financing structure, and oversight of low-income housing projects and community facilities in a manner that will meet the long-term needs of low-income residents and their communities. Enterprise Community Loan Fund served as an information resource for nonprofit groups involved in the acquisition, development, ownership, and management of low-income housing and community facilities. In this capacity, it responded to inquiries from nonprofits, typically local, community-based organizations that needed information or had questions about specific issues involving the provision of decent, safe, affordable housing to low-income persons and facilities. Enterprise Community Loan Fund was not compensated for this activity.
