THE TOTAL NUMBER OF FOOD BOXES PROVIDED WAS 1,413 WHICH REPRESENTS A DECREASE FROM 2011 IN WHICH 2,589 FOOD BOXES WERE PROVIDED. HOWEVER, THE BREAD AND GROCERY AISLE USAGE HAS INCREASED DRAMATICALLY FROM 22,201 RECIPIENTS IN 2011 AND THIS SERVICE HAS SIGNIFICANTLY DECREASED THE NEED FOR FOOD BOXES AS ONGOING AVAILABILITY OF THE BREAD AND GROCERY AISLE PROVIDES THE FOOD THAT IS NORMALLY NEEDED.
