CONGRESSIONAL INTERNSHIP PROGRAM - THE 2013 CBCF CONGRESSIONAL INTERNSHIP SESSION BEGAN ON SUNDAY, MAY 27 WITH 44 INTERNS ARRIVING IN WASHINGTON, DC THE INTERNS WERE HOUSED ON THE CAMPUS OF GEORGE WASHINGTON UNIVERSITY (GWU) UNDER THE SUPERVISION OF TWO RESIDENT ASSISTANTS TO ADDRESS AND REPORT ANY RESIDENTIAL CONCERNS THE INTERNS ALSO RECEIVED A \$3,000 STIPEND PRIOR TO BEGINNING WORK IN CBC MEMBER OFFICES, THE INTERNS COMPLETED ONE WEEK OF ORIENTATION ACTIVITIES (TUESDAY-FRIDAY) SOME OF THE ORIENTATION EVENTS AND ACTIVITIES PLANNED FOR THE WEEK INCLUDED A TOUR OF CAPITOL HILL, TRAINING ON HOW TO ACCESS AND EFFECTIVELY USE THE CONGRESSIONAL RESEARCH SERVICE (CRS), SEMINARS TO ENHANCE THEIR LEADERSHIP AND PROFESSIONAL DEVELOPMENT, A VISIT TO THE MARTIN LUTHER KING, JR MEMORIAL, AND A SEMINAR ON FINANCIAL LITERACY THE INTERNS HAD THE UNIQUE OPPORTUNITY TO ATTEND WEEKLY LEADERSHIP FORUMS HOSTED BY CBC MEMBERS DURING THESE FORUMS, THE INTERNS WERE PRIVILEGED TO HEAR THE CBC MEMBERS' VIEWS ON LEADERSHIP, PRESSING PUBLIC POLICY ISSUES, AND CHALLENGES FACING THE MILLENNIAL GENERATION ADDITIONALLY, THE INTERNS HAD THE OPPORTUNITY TO ATTEND PROFESSIONAL DEVELOPMENT EVENTS - THESE EVENTS PROVIDED THE INTERNS WITH AN OPPORTUNITY TO INTERACT WITH REPRESENTATIVES FROM GRADUATE SCHOOLS, FEDERAL AGENCIES, AND OTHER COMPANIES THAT ARE INTERESTED IN RECRUITING CBCF INTERNS LASTLY, THE INTERNS PARTICIPATED IN A CONGRESSIONAL SIMULATION ENTITLED "CONGRESS IN ACTION" THIS SIMULATION AFFORDED THE INTERNS AN OPPORTUNITY TO ACQUIRE HANDS ON EXPERIENCE WITH RESEARCHING, WRITING, DEBATING AND PASSING A CONGRESSIONAL BILL
