STA Training School, Inc. ("Training School") is a corporation formed by the Steamship Trade Association of Baltimore, Inc. (STA), a trade association of maritime employers, carriers and service companies exempt from federal income tax under section 501 (c) (6) of the Internal Revenue Code. The officers and board members of the Training School are all officers of the STA.

The Training School utilizes funds from the Carrier-ILA Container Freight Station Trust Fund ("CFS Fund") managed by the United States Maritime Alliance, Ltd. (USMX). The STA is a port association member of USMX, which is an umbrella association of maritime employers, carrier and port associations covering the East and Gulf Coasts of the United States.

CFS Funds are used by the STA to provide specialized training to newly hired and experienced longshore personnel in Baltimore represented by the International Longshoremen's Association, AFL-CIO (ILA). The Training School courses encompass safety orientation, powered industrial truck training, crane training, and other skills training essential for safe and efficient port operations in Baltimore.
