

**Show Website**

In Fall 2012, COMPTEL launched a new and improved COMPTEL *PLUS* website – [www.comptelplus.org](http://www.comptelplus.org) – which features responsive technology. This technology enables visitors to view the website optimally from any screen – smartphone, tablet, laptop or desktop.

**Spring 2012 – San Francisco**

The COMPTEL *PLUS* Spring 2012 Convention & EXPO was held at the Marriott Marquis in San Francisco, April 15-18. The show featured a keynote address from innovation guru Phil McKinney, author of the book “Beyond the Obvious: Killer Questions that Spark Game-Changing Innovation.” McKinney challenged the audience to escape old ways of thinking and develop a culture at their companies that inspire the creative process and encourage innovation.

At this show, COMPTEL also launched the COMPTEL *PLUS* MAP, a smartphone/tablet app designed to help attendees navigate the show and access the Business PLANner while mobile. The initial use was promising, with more than 860 individual IP addresses accessing the COMPTEL *PLUS* MAP before and during the show.

Key statistics from the Spring show include:

- More than 2,200 registered attendees
- 22 registered members of the media and industry analysts
- More than 900 attendees used the Business PLANner to schedule meetings in the EXPO hall and deal center, and participated in almost 325 meetings with prospective and current customers.
- EXPO featuring 105 companies – including 15 first-time exhibitors

- CEO Breakfast attended by 56 C-level executives.

During her remarks, Herda showcased the importance of innovation and called for the FCC to embrace smart, forward-looking competitive telecom policy with price and service quality rules where incumbents have market power, regardless of technology used.
