MANY FAMILIES ARE FORCED TO CHOOSE BETWEEN FEEDING THEIR FAMILIES AND BUYING MEDICINE. VOUCHERS ARE SUPPLIED FOR CARE ARRANGED THROUGH A NETWORK OF PHARMACISTS. IN 2012, 711 INDIVIDUALS WERE HELPED WITH OVER 1,293 PRESCRIPTIONS AND 320 INDIVIDUALS WERE HELPED WITH DENTAL ASSISTANCE.
