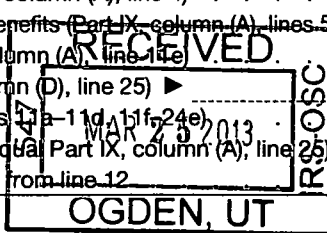

The state-of-the-art planetarium, in a free 20-minute presentation, shows a NASA launch film, some history of astronomy, pictures from the Hubble telescope, and other cosmic events including a graphic depiction of the future according to Holy Scripture. After viewing the planetarium presentation, guests are offered spiritually educating CD's, DVD's, and other material. All guests to the facility are encouraged to take a free magazine (illustrated with our exotic birds) and other publications to assist in their study of scripture and to learn how to deal with the stresses of life. Various media outreaches are also promoted to teach how to cope with life in a positive manner.

In 2012, more than 95,000 guests visited the facility.
