THE ILSI NORTH AMERICA FOOD MICROBIOLOGY COMMITTEE IS COMMITTED TO PROACTIVELY IMPROVING THE UNDERSTANDING AND CONTROL OF MICROBIAL FOOD SAFETY HAZARDS TO ENABLE SCIENTIFICALLY INFORMED DECISION MAKING. FUNDING RESEARCH REMAINS AN IMPORTANT FOCUS FOR THE COMMITTEE WHICH HAS UNDERTAKEN A STUDY TO INVESTIGATE FOOD MICROBIAL CONTAMINATION OF CANTALOUPE, HONEYDEW AND WATERMELON BY INVESTIGATORS AT THE UNIVERSITY OF CALIFORNIA, DAVIS TWO ADDITIONAL RESEARCH STUDIES, INCLUDED IN THE 2012 RESEARCH CYCLE, FOCUS ON AN AREA IN NEED OF SOLUTIONS FOR DRY SANITATION PROCESSING SYSTEMS. THE FIRST STUDY, BEING CONDUCTED AT MICHIGAN STATE UNIVERSITY, IS INVESTIGATING A CUTTING EDGE TECHNOLOGY USING HIGH-FREQUENCY NANO-AMPLITUDE MECHANICAL VIBRATION FOR PREVENTING AND REDUCING SALMONELLA ON DRY SURFACES. THE SECOND STUDY, CONDUCTED AT THE INSTITUTE FOR FOOD SAFETY AND HEALTH AT ILLINOIS INSTITUTE OF TECHNOLOGY, IS ATTEMPTING TO ESTABLISH BEST PRACTICES FOR CLEANING AND SANITIZING NUT BUTTER PROCESSING EQUIPMENT. ISOLATES FROM THE ILSI NORTH AMERICA L. MONOCYTOGENES, E. SAKAZAKII, AND SALMONELLA REFERENCE STRAIN COLLECTION, HOUSED AT CORNELL UNIVERSITY, ARE DISTRIBUTED FOR A MINIMAL CHARGE TO RESEARCHERS AROUND THE WORLD. THE COMMITTEE HELD ITS ANNUAL SYMPOSIUM SERIES AT THE 2012 MEETING OF INTERNATIONAL ASSOCIATION FOR FOOD PROTECTION IN PROVIDENCE, RHODE ISLAND. FEATURED SPEAKERS REPORTED ON SALMONELLA IN LOW MOISTURE FOODS, A CONTINUED CHALLENGE, CURRENT CONTROVERSIES IN FOOD SAFETY, AND IMPACT OF INTERNATIONAL TRADE ON FOOD SAFETY
