**Judicial Independence:** Independence of the judicial branch is fundamental for the good function of the Rule of Law. Likewise, independence is a precondition for impartial application of the law - to all persons equally - and is an essential component for strengthening the judicial sector in Latin America. Thus, under our Judicial Independence Program we promote an independent judicial sector focusing on three areas: transparency and judicial corruption, selection of judicial officials, and the impact of undue pressures on the overuse of pretrial detention. In 2012, we have helped heighten awareness of the importance of judicial independence and the role of the judiciary in a democratic society focusing on Central America in particular. Through applied research, building of strategic alliances, advocacy and communications activities we helped our local partners in El Salvador stave off a serious attack on judicial independence in the Constitutional Chamber of the Supreme Court.

**b. Human Rights & Extractive Industries:** While the reasons for a growing number of social conflicts in Latin America are associated with the extraction of natural resources and major infrastructure development projects, these projects represent an important, and much needed, source of income for Latin America. Nevertheless, responsibility for observing international and national human rights standards and norms must be assumed by the host States, the corporations carrying out the projects, and the States from which international extractive companies hail. Furthermore, all stakeholders must recognize and respect the rights of indigenous groups to their land and territory, and their right to prior consultation in these projects. Through our Human Rights & Extractive Industries Program, DPLF promotes the use of existing international and national legal and institutional mechanisms in resolving conflicts related to natural resources extraction in coordination with international human rights norms and standards. Respect for the rights of those affected by these projects is fundamental for democracy and peace in Latin America. This year, in addition to working on a study related to the responsibilities of home states for the human rights violations of their (mining) companies in Latin America, DPLF continued to monitor rulings from upper courts and constitutional tribunals on indigenous peoples' right to consultation.

**c. Transitional Justice:** The investigation, prosecution and reparation of past grave violations of human rights remain a pending debt in Latin America. This lack of justice has serious repercussions for the present, and reflects the weakness of the judicial systems in the region. Through our Transitional Justice Program we urge accountability for grave violations of human rights committed in Latin America and promote the incorporation of international human rights standards in national justice systems. The focus for 2012 under our Transitional Justice Program was the compiling of a second and third volume of our Digest on Latin American jurisprudence on on international crimes (to be launched in 2013) in which we document the growing number of decisions in the region that apply international human rights law.

inter American human rights protection system, which incorporates the Inter American Commission (IACHR) and Court on Human Rights, constitutes the regional framework for the protection and promotion of human rights in the Americas. The member States of the Organization of American States established the system and charged it with monitoring respect for the international human rights instruments they themselves ratified. Through our Strengthening of the Inter American Human Rights System Program, DPLF monitors the OAS on human rights issues and carries out applied research and advocacy activities, as well as promotes informed dialogue amongst users of the Inter American Human Rights System to promote continuation of the system's human rights legacy. In 2012 DPLF was instrumental in mitigating the effects of an aggressive attack on the IACHR by certain member states intent on limiting its autonomy and reach. While supporting the IACHR through this intense period, DPLF continued to request and hold public thematic hearings before the IACHR seeking, in close coordination with our local allies, to focus attention on various issues related to our programmatic work.
