WE WORK WITH MEMBERS OF CONGRESS, KEY ADMINISTRATION OFFICIALS, OTHER NONPROFIT ORGANIZATIONS, MEDIA OUTLETS, AND THE BROAD PUBLIC TO PROMOTE SYSTEMIC CAMPAIGN FINANCE REFORM. WE IDENTIFY CHALLENGES FACING POLICY MAKERS AND MEMBERS OF THE PUBLIC INTERESTED IN MAKING THE CAMPAIGN FINANCE SYSTEM MORE INCLUSIVE AND RESPOND BY CONDUCTING CAREFUL RESEARCH AND DISSEMINATING OUR FINDINGS WIDELY.
