SSDP HOSTED A CONFERENCE TO TRAIN COLLEGE STUDENTS IN STORYTELLING AND CAMPUS ORGANIZING SKILLS. IT WAS HELD IN DENVER, COLORADO WITH APPROXIMATELY 400 STUDENTS IN ATTENDANCE. THE NATIONAL STAFF ALSO ORGANIZED SEVERAL ONE-DAY REGIONAL CONFERENCES FOR OUR STUDENT DRUG POLICY ACTIVISTS. TOPICS INCLUDED FUNDRAISING, PERSUASION, COMMUNICATION, DELEGATION, AND CHAPTER MANAGEMENT. IN JANUARY 2012, DOZENS OF OUR STUDENTS ATTENDED THE GOP COLLEGE CONVENTION IN CONCORD, NEW HAMPSHIRE. WE WERE ABLE TO GET EACH GOP PRESIDENTIAL CANDIDATE ON THE RECORD ABOUT THEIR VIEWS ON DRUG POLICY AND REFORM.
