In addition, employees may not use their positions at HCWH for personal benefit, for the benefit of friends or relatives, or to further any outside interests or personal agenda. If a conflict or potential conflict arises, employees under the policy may consult with the Executive Director, their supervisor or Human Resources. If the Executive Director considers a possible conflict of interest exists, they are required to report this to the President.
