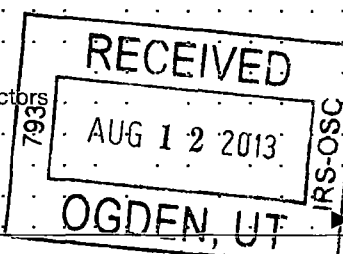

Friends of Blackwater 2012 Projects

Blackwater Canyon and Trail Protection: Friends of Blackwater continues to work to protect the federally owned Blackwater Canyon Rail Trail. We distributed trail maps and have them on our website. We pressured the Forest Service to put interpretive signage along the Rail Trail and they put up a nice kiosk with benches and signage about the early coal and coke industry along the Trail at the coke ovens. We designed and printed a brochure on the coal and coke industry of Coketon which we hand out at our Davis, WV Office. We reviewed a proposed water line installation along the Rail-Trail as part of the 309 historic review process to which we are a party.

Total expenses - \$51,942.61

Save Our Squirrel (SOS): Friends of Blackwater lost an appeal of our case asking that the rare West Virginia northern flying squirrel be returned to the endangered species list in November 2012. Ginny is the most unique mammal of the Allegheny Highlands and the signature species of Blackwater Canyon. We worked with the Monongahela National Forest to insure that the squirrel's protections continues on this federal land. Under this program we also advocate for the little brown bat, threatened by white nose syndrome and other rare species of West Virginia. We continued to advocate for stronger regulation to protect all avian species threatened by industrial wind projects.

Total expenses - \$44,859.75

North Fork Watershed Project (NFWP): This project was created in 2002 to improve this gateway to the Blackwater Canyon. The North Fork flows along the Blackwater Canyon Rail Trail and is negatively impacted by acid mine drainage pollution. The Project finished building system in the Thomas City Park along the North Fork and completed a map and brochure to help people navigate the trails. Our Vista Volunteers and employees monitor water quality in the North Fork with volunteer help. We continued to monitor headwater streams that flow through Blackwater Falls State Park to analyze their potential for remediation and native brook trout reintroduction. The North Fork staff also attended events and gave out maps and history brochures on the area.

Total expenses - \$38,299.94

The J.R. Clifford Project:

JR Clifford Project educates citizens about West Virginia's first African-American lawyer, who fought in the Civil War, was a newspaper publisher and a co-founder of the Niagara Movement, the predecessor of the NAACP. To honor the State's 150 birthday, we created and put on a living history drama: "A New Home for Liberty, Human Rights, Slavery and the Creation of West Virginia". The play was put on in Shepherdstown at Shepherd University with a matching public forum in Martinsburg WV. Scholars took part in the programs and commented on the Civil War period. Approximately 1,500 people attended the drama, seminars and school programs built around the play.

Total expenses - \$31,757.83

MON PLAN: Protecting the Monongahela National Forest in West Virginia's High Allegheny Mountains

Friends of Blackwater set up the Eastern National Forests Gas Drilling Working Group and joined with three other national forest advocacy groups to review and object to problematic gas drilling proposals on these public lands. We collaborated on an educational website on fracking on public lands particularly eastern national forests. We also reviewed and commented on timber proposals that could impact endangered and rare species on the Mon.

Total expenses - \$27,365.66
