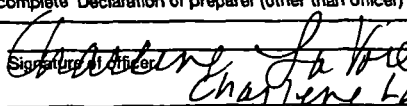

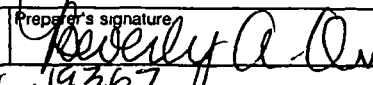

The Law Works is a nonprofit, tax-exempt organization that works to promote a greater understanding of the law and the civil justice system.

First, the portion of the Law Works support that qualifies as eligible public support regularly exceeds the the 10 percent threshold required under Treasury Regulation section 1.170A-9(e)(3)(i). In 2010, the portion of the Law Works support that qualifies as eligible public support was 69.42 percent. In 2011, the portion of the Law Works support that qualifies as eligible public support was 25.58 percent. And, in 2012, the portion of the Law Works support that qualifies as eligible public support was 30.70 percent.

Second, the Law Works operations are expanding to ensure that it will continue to attract new and additional public support, as required by Treasury Regulation section 1.170A-9(e)(3)(ii). The Law Works is developing an active fundraising program targeting individuals, and private foundations. These efforts and the fact The Law Works exceeds the 10 percent threshold requirement mean The Law Works satisfies the threshold requirement for qualifying as publicly supported under the facts and circumstances test.

In determining whether The Law Works meets the "facts and circumstances test," the Treasury Regulations also provide a list of factors that serve as indicia of whether an organization qualifies as "publicly supported." The higher the percentage of support above the 10 percent requirement, the lower the organization's burden in establishing its publicly supported nature with other factors. These additional factors, discussed below, provide additional evidence that The Law Works satisfies the facts and circumstances test.

Sources of Support -- The Law Works is not controlled by a small number of individual donors or private foundations and the bulk of if its funding is from public charities.

Representative Governing Body -- The Law Works has a representative governing body committed to educating the general public about a variety of legal issues. Three of the five board members are lawyers committed to public education, one is an aeronautical engineer with a history of community participation, and one is PhD with a strong background in conservation and civic engagement. The representative nature of an organization's governing body is also a factor in determining whether it qualifies under the "facts and circumstances test." In considering whether a board is representative, relevant factors are the members' expertise in the relevant field, their history of leadership in the community, and their tradition of public service.

Attorney Barry Boodman specialized in municipal and civil rights litigation, for both plaintiffs and defendants. He is a former Deputy

Corporation Counsel for the City of Stamford, CT and now lives in Mystic, CT.

He has also done field work in Panama and French Guiana. Tarek designed the palm climbing gear and fuel tank. He founded Caura Futures in 2005 and serves as its director.

Fred Silverio, is a life-long resident of Winsted, CT and is an aeronautical engineer with a history of robust community participation.

Public Participation Programs -- The Law Works also has active public participation in its programs, providing services for the benefit of the public on an ongoing basis and having members of the public who are technical experts participating in its programs. Accordingly, the Law Works qualifies as a "publicly supported" organization described in section 170(b)(1)(A)(vi).

The Law Works recently sponsored a series of talks at The Mystic and Noank Library in Mystic, CT. The Law Works presented Attorneys Barry Boodman and Charlene LaVoie for an interactive discussion on contemporary topics sponsored by The Law Works.

The series began with a talk about the changes in Connecticut law to the Freedom of Information Act that adversely impact citizens' right to know what the government is up to and how the Governor supports

The second presentation focused on the reasons that the United States Post Office is in jeopardy and what interested citizens could do to help save local Post Offices in rural communities.

The third presentation outlined the ramifications of the Supreme Court case, Citizens United, and examined the impact of corporate campaign contributions on the electoral system.

The fourth presentation we examined tort reform through the controversial 1992 hot coffee lawsuit against McDonalds. This presentation showcased the 2011 documentary film Hot Coffee that analyzes and discusses the impact of tort reform on the United States judicial system.

These presentations were free and open to the general public.
