At December 31, 2012 and 2011, there was a federal net operating loss carryforward of \$294,922 and \$238,013, respectively, and a state net operating loss tax carryforward of \$230,243 and \$176,929, respectively. The net operating loss carryforwards begin to expire in 2025 for federal purposes and 2020 for state purposes.

NCAR's wholly-owned subsidiaries are subject to federal and state corporate income taxes. At December 31, 2012, NCAR Service Corporation had no federal tax liability.
