They determine if the tissue is suitable for transplant and work with surgeons to meet their patients' needs. They also facilitate providing tissue to researchers working on cures for eye disease such as macular degeneration and glaucoma. The Organization is one of the largest providers of sclera for oculo-plastic surgery and glaucoma surgery.

RECOVERY SERVICES - oversees the surgical recovery and preservation of donor ocular tissue.
