THE FARM IS USED AS A TEACHING TOOL FOR AGRICULTURAL PRODUCTION, AND AS A MEANS FOR IFFS TO INCREASE FRESH FOOD PRODUCTION FOR DISTRIBUTION BACK INTO THE COMMUNITY. IFFS COMBINED NUTRITION EDUCATION WITH THEIR MOBILE MARKETS AND HAD 3,444 PARTICIPANTS.
